All Cooking Booths and Vendors using open flame shall comply with the

2022 California Fire Code

Chapter 31 Tent and other Membrane Structures

3103.8.2 Location - Tents or membrane structures shall not be within 20' feet of lot lines, buildings, or other tents or membrane structures, parked vehicles or internal combustion engines. For the purpose of determining required distances, support ropes and guy wires shall be considered as part of the temporary membrane structure or tent.

3107.4 Open or Exposed Flame. Open flame or other devices emitting flame, fire or heat or any flammable or combustible liquids, gas, charcoal or other cooking device or any other unapproved devices shall not be permitted inside or located within 20' feet of the tent or membrane structures while open of the public unless approved by the fire code official.

3107.12.5 Cooking Tents. Tents with sidewalls or drops where cooking is performed shall be separated from other tents or membrane structures by a minimum of 20' feet.


3107.12.6 Outdoor Cooking. Outdoor cooking that produces sparks or grease laden vapors shall not be performed from other tents or membrane structures by a minimum of 20' feet.

See Table 6104.3 For Containers 500 gallons or less distances. Portable LP-gas containers with a capacity of 500 gallons or less shall have a minimum separation between the container and structure not less than 10' feet.

3107.13.3 Protection and Security. Portable LP-gas containers, piping, valves and fittings which are located outside and are being used to fuel equipment inside a tent or membrane structure shall be adequately protected to prevent tampering, damage by vehicles or other hazards and shall be located in an approved location. Portable LP-gas containers shall be securely fastened in place to prevent unauthorized movement.




FARMERS VENDOR AND COOKING BOOTH LOCATIONS




Note: Cooking Booths are limited to single rows only. Back-to-back rows are not permitted. Maximum length of row is 100 feet.


