Neville Connell of GAFSC explained the background on the program and the current scope of projects the GAFSC is currently requesting from the Sunrise PowerLink Fire Mitigation Grants Program. As an employee of Sempra Energy, Director Taylor recused himself and left the room from further discussion and the vote.

Chief Paskle was pleased to announce that he would be confident in recommending all of them for promotion. Number one on the list was Firefighter/Paramedic Shane Ozbirn. The oral interviews for PT Admin Assistant will be finished this week and the Seasonal Weed Abatement Inspector recruitment has been extended.
 - Fire Chief reported that a blood drive in honor of local resident Luke Hayworth will be at the station on Sunday, June 16th.

Fire Chief added that with the hiring of the Inspector and CalFire it is anticipated that all the residents in the jurisdiction will be visited.
